


# Integration of Caregivers into Care Teams

- . Is key to quality of life
- · Must be purposeful and meaningful
- Involves open communication, negotiation, and collaboration
- Requires environments that support empowerment





## **Caregiver Centered Care Competency Framework**



**Partnering with Family Caregivers Competency Indicators 1. Understands the benefits of including** family caregivers on the care team. **2.** Establishes collaborative relationships with family caregivers. **3.** Includes family caregiver's knowledge of the care recipients in assessments and care planning. 4. Understands conflicts and works to deescalate conflict.

# Partnering with Family Caregivers

Health workforce education to support family caregivers

Based on public health direction or local or regional status of COVID-19 cases it may be necessary to prohibit visitors. A "no visitor" policy should be strongly considered.

(Government of Canada, 2020)



Similarly, the voices, perspectives, and expertise of older persons in identifying problems and solutions are sometimes not sufficiently incorporated in policy-making, particularly on subjects where older persons are affected by the decisions under consideration.

Harness their knowledge and ensure their free, active, and meaningful participation.



It was critical to enact public health measures to control the spread of COVID-19 and to protect those at high risk for serious health outcomes. However, existing health inequities meant that some groups most at risk from COVID-19 were the same populations disproportionately impacted by public health measures.

- 'I wanted dad to be safe but then realized it was causing more harm than good'
- Putting yourself in someone else's shoes how would you do things differently?
- Becoming a different caregiver geographical distance, transition into LTC, changes in care needs
- When you hear a patient story listen, attend, and evaluate your practice
