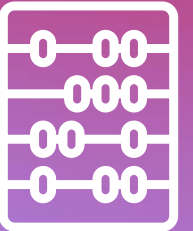

About this Community of Practice (COP)

Who is it for

- Administrators and clinicians from across Canada who work in the Long-Term Care setting who have a desire to continuously improve they deliver a palliative approach to residents and their close ones

Main goals

- To identify palliative-care related QI opportunities in the Long-Term Care setting
- To develop Quality Improvement Toolkits as a resource for those who wish to implement these kinds of projects
- To support teams who are implementing these quality improvement initiatives

Role of the core group

- Identify short list of QI priorities, refine root causes that have been identified etc.
- Create prototype QI toolkit
- Seek input from the broader COP the prototype QI toolkit
- Provide ongoing support and mentorship to practices who decide to engage in these QI activities through these COP meetings

Role of the broader Community of Practice

- Help to determine which QI priorities to focus on first, identify root causes, barriers/ facilitator etc.
- Provide feedback on the QI Toolkit prototype
- To implement and champion quality improvement initiatives in their care settings

What is QI

- A philosophy to continuously make things better
- Application of Best Practice
- Can refine/ improve with new knowledge produced
- Uses multiple methods/ tools to implement change & measure the impact

“An organizational philosophy that seeks to meet clients’ needs and exceed their expectations by using a structured process that selectively identifies and improves all aspects of service.”

Accreditation Canada

A QI intervention is dependent on the nature and aim of the QI goal

QI Intervention	Example of Activities	Aim of QI Project
LTC staff education	Workshops, training sessions, educational outreach visits, distribution of educational materials	Increase knowledge and use of evidence-based practices of LTC staff managing pain for residents in LTC
Organizational Change in Care Delivery	Multidisciplinary teams, increased staffing, use of pain protocol, change from paper to computer-based records, regular assessments and documentation	Reduce pain in residents in LTC

Donabedian's Measures (1966)

Proposed 3 types of measures for assessing the quality of healthcare:

- Structures
- Processes
- Outcomes

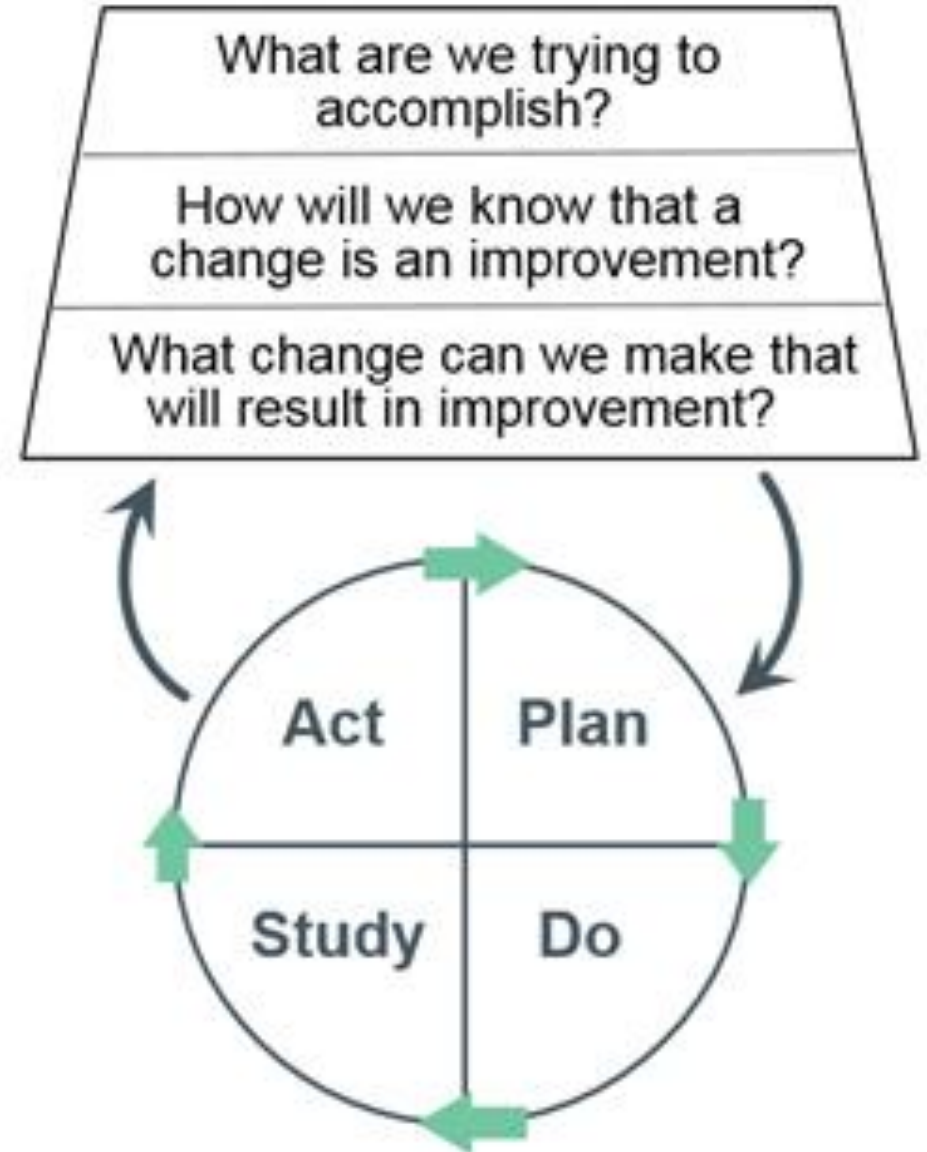
These measures remain the foundation of QI today

PDSA Cycle

1. **PLAN:** Plan a change or test of how something works.
2. **DO:** Carry out the plan.
3. **STUDY:** Look at the results. What did you find out?
4. **ACT:** Decide what actions should be taken to improve.

Repeat as needed until the desired goal is achieved
